



LIMITED WARRANTY

LogRite Tools warrants to its original consumer purchaser that all aluminum handles included as part of any LogRite Tools Peavey and Clark products will be free of defects in material and workmanship, when properly used and maintained, for so long as the LogRite Tools product is owned by the original consumer purchaser. All other products, or parts of products, manufactured by LogRite Tools, when properly assembled in accordance with LogRite Tools' assembly instructions, and properly used and maintained, shall be free from defects in material and workmanship for a period of one (1) year from the date of original purchase.

If a defect arises and a valid claim is received by LogRite Tools within the Warranty Period, LogRite Tools will, as its sole and exclusive obligation and at its option, either (1) repair the product at no charge, using new or refurbished replacement parts, (2) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the original purchase price of the product.

LogRite Tool's warranty obligations are further limited to the terms set forth below:

- This warranty does not cover any damages due to accident, misuse, abuse, negligence or failure to properly use or maintain any products. In the event that any products are altered or repaired by anyone without the prior written approval by LogRite Tools, all warranties are void.
- To initiate a warranty claim, the owner of an LogRite Tools product must provide its place of purchase, in writing to the company's address listed below or as changed from time to time, with a full description of the product, its Serial Number, dates of purchase, and the exact nature of the defect.
- If requested by LogRite Tools, any defective product must be returned, freight prepaid, to LogRite Tools' designated factory location for inspection. LogRite Tools will repair or replace the failed or defective product, at its option, and deliver the repaired product or replacement to the seller of the product, freight prepaid to the destination provided for in the original order. Products returned to LogRite Tools for which LogRite Tools provides replacement under this limited warranty shall become the property of LogRite Tools.
- A new warranty period shall not be established for repaired or replaced products. Such products shall remain under warranty only for the remainder of the warranty period on the original products. This limited warranty gives the holder specific rights, and the holder may also have other rights that vary from state to state.
- This written limited warranty constitutes the final, complete and exclusive statement of warranty terms. No person or organization is authorized to make any other warranties or representations on behalf of LogRite Tools.
- TO THE MAXIMUM EXTENT PERMITTED BY LAW, THIS WARRANTY AND THE REMEDIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, REMEDIES AND CONDITIONS, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED. LOGRITE TOOLS SPECIFICALLY DISCLAIMS ANY AND ALL IMPLIED WARRANTIES, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IF LOGRITE TOOLS CANNOT LAWFULLY DISCLAIM OR EXCLUDE IMPLIED WARRANTIES UNDER APPLICABLE LAW, THEN TO THE MAXIMUM EXTENT POSSIBLE ANY CLAIMS UNDER SUCH IMPLIED WARRANTIES SHALL EXPIRE ON EXPIRATION OF THE WARRANTY PERIOD. NO LOGRITE TOOLS RESELLER, AGENT, OR EMPLOYEE IS AUTHORIZED TO MAKE ANY MODIFICATION, EXTENSION, OR ADDITION TO THIS WARRANTY.
- TO THE MAXIMUM EXTENT PERMITTED BY LAW, LOGRITE TOOLS IS NOT RESPONSIBLE FOR DIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM ANY BREACH OF WARRANTY OR CONDITION, OR UNDER ANY OTHER LEGAL THEORY.
